Take Northeast Extension of the PA Turnpike (I476) South to Exit 34 (Mahoning Valley), go West on Route 209 to Route 248. Turn East on to Route 248 to Route 145. Go South on Route 248 to Route 145. Go South on Route 145 to Walnutport. Turn Right at the traffic light on to Main Street. Locktender's House is located one block South of Main Street on Lehigh Street
